

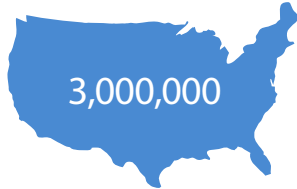

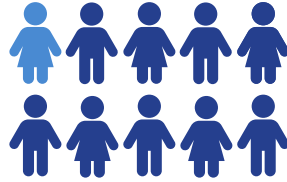


# The Problem

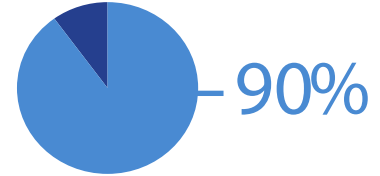

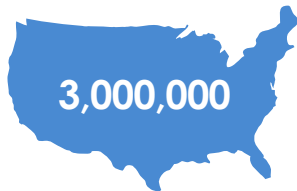

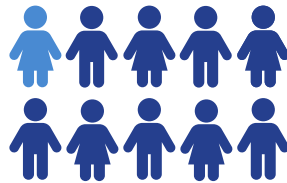
# The Problem

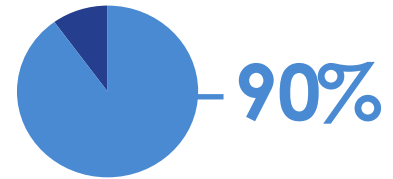

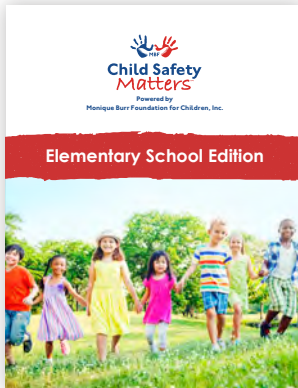
